Think of this company as another middle-man restricting you to receiving the benefits you are entitled to and pay for. Your insurance provider has given eviCore the authority to approve or deny your Physical Therapy benefits based on their statistics, not based on you the patient and your specific needs. This company has led to slower recoveries due to limiting your treatment frequency and amount, as well as leading to unnecessary gaps in treatments while waiting for their approval or denial.
